MINUTES OF THE 27TH REGULAR SESSION OF THE 8TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE SESSION HALL ON JULY 20, 2011.

MUNICIPAL ORDINANCE NO. 2011-0703

"AN ORDINANCE PROHIBITING THE OPERATORS THE SALE OF INTOXICATING DRINKS AND/ OR INTOXICATING BEVERAGES IN THE MUNICIPALITY OF SAN PABLO TO MINORS".

Be it ordained by the Sangguniang Bayan of San Pablo, Zamboanga del Sur in Session assembled;

Section 1. Definition of terms. As used in this Municipality the following words or phrases, shall have the following meanings:

- a. Intoxicating drink and / or intoxicating beverages includes tuba, beer, basi, gin, rum, whisky, brandy, cognac, champagne, vodka, as well as other kinds of brew with intoxicating effect included in the definition of intoxicating drinks and /or intoxicating beverages are the mixtures of any of the aforementioned intoxicants with non- intoxicating beverages.
 - b. Operators - means the owner and/or manager of a store, carinderia, establishment, restaurant or hotel, where intoxicating beverages are served to customers. Included in the definition of operators as use herein are the operators of bars or cocktail lounges, night clubs and /or day club, dance halls and cabarets dancing schools.
 - c. Customers are the person who drink, imbibe, or bought the intoxicating beverages inside or outside the operator's premises.
 - d. Minors means customers below the age of eighteen (18)

Section 2. It shall be unlawful and strictly prohibited for any operator to serve or to sell Intoxicating drinks or Intoxicating beverages to a customer who is a minor.

Section 3. Penal Provisions- any violation of the provisions of this article shall be punished by a fine of not less than Two Hundred (P200.00) pesos but not more than Five hundred (500.00) pesos or suffer an imprisonment of not less than 1 (one) month or not more than Six (6) months, or both a fine and imprisonment at the discretion of the court .

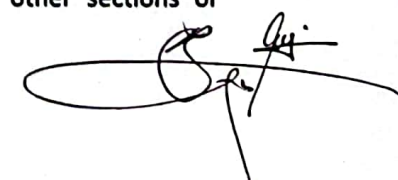


Section 4. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.

Section 5. Effectivity. This Ordinance shall take effect immediately after public hearing and 15 days after its third and last publication in a newspaper.



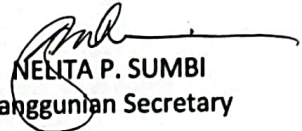
Section 6. Separability Clause. Any section or provision of this ordinance which may declared unlawful or unconstitutional shall not affect the other sections or provision hereof.



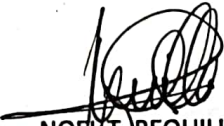
