MUNICIPAL ORDINANCE NO. 2011-0704

"AN ORDINANCE PROHIBITING MINORS TO LOITER FROM 10:00 AT NIGHT TO 4:00 IN THE MORNING IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR".

Be it ordained by the Sangguniang Bayan of San Pablo in Session assembled;

Section 1. Definition of terms. Words phrases as used in this ordinance. The following terms, words, or phrases shall have the meaning as indicated below:

- a. Minor a minor is any person whose age is below eighteen (18) years old.
- Loiter the word loiter means being outside one's home and or outside the premises of business establishment during the prohibited time.

Section 2. All persons who are minor ages shall be prohibited to loiter around within the premise of the Poblacion of the Municipality of San Pablo, this Province after 10:00 in the evening to 4:00 in the morning.

Section 3. Exemption. When said minor is in compliance of parental advice/instructions acting emergency cases, benefit dances, and other SK related activities.

Section 4. the PNP team command, all public and barangay officials shall extend all their tangible support and enforcement of this ordinance.

Section 5. Minors who will be caught violating this Ordinance will be detained for safekeeping, a fine of the following:

1st Offense

- P 500.00

2nd Offense

- P1,000.00

3rd Offense

- P2.000.00

Section 6. The Municipal Social Welfare and Development Officer shall assist the PNP in implementing this Ordinance.

Section 7. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.

Section 8. Effectivity. This Ordinance shall take effect immediately after approval of the Municipal Mayor and 15 days after its third reading and last publication in a
