ORDINANCE NO. 2011-0706

**"AN ORDINANCE REGULATING THE SPEED LIMIT OF ALL VEHICLES TO TWENTY FIVE KILOMETERS PER HOUR, WITHIN THE RADIUS OF ONE (1) KILOMETER FROM THE CENTER OF POBLACION".**

Be it ordained by the Sangguniang Bayan of San Pablo, Zamboanga del Sur that;

**Section 1. Title and Purpose** – This ordinance shall be known as a ordinance regulating the speed limit of all vehicles to twenty five (25) kilometers per hour, within the radius of one(1) kilometer from the center of Poblacion, San Pablo, Zamboanga del Sur.

**Section 2. Scope and Jurisdiction** – This ordinance shall be applicable to all types of vehicles, private or government owned who will enter within the radius of one(1) kilometer away from the center of Poblacion.

**Section 3.** No vehicles is allowed to take a run beyond the speed limit of twenty five (25) kilometers per hour, within the radius of one kilometer from the center of Poblacion

**Section 4.** the Speedometer of every vehicle should function at lest five (5) months after implementation of this ordinance.

**Section 5.** There must be signboards displayed one (1) kilometer radius from the center of Poblacion, indicating the twenty five (25) kilometers speed limit.

**Section 6.** Definition of terms.

- a. Vehicle - a means of carrying or transporting something.
- b. Speed limit - the maximum or minimum speed by law in a given area under specified circumstances.
- c. Radius - the distance from a center line or point to an axis of rotation.
- d. Speedometer - an instrument for indicating distance traversed as well as speed of travel.

**Section 7. Penal Clause** – Any person/s found violating this ordinance shall upon conviction be punished by a fine of not less than Ten (Ph10.00) pesos but not more than Two Hundred (Ph200.00) pesos or an imprisonment of two (2) days but not more than Ten (10) days or both such fine and imprisonment upon the discretion of the court.

**Section 8. Separability Clause** – If any portion or provision of this ordinance is declared unconstitutional or invalid, the other portion or provisions hereof, which are not affected thereby, shall continue in full force and effect.

**Section 9. Effectivity** – Upon approval by the local Chief Executive and the Sangguniang Panlalawigan, this ordinance shall take effect and be enforceable ten (10) days after its posting in the newspaper and in two (2) other conspicuous places within the Municipality.

**ENACTED AND APPROVED** on this 20<sup>th</sup> day of July 2011 during the 27<sup>th</sup> regular session of the Honorable Sangguniang Bayan members of San Pablo, Zamboanga del Sur.

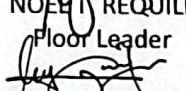
