EXCERPT FROM THE MINUTES OF THE 22ND REGULAR SESSION OF THE 7TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE SESSION HALL ON MARCH 30, 2011.

RESOLUTION NO. 201103089

WHEREAS, appropriation for the repair and maintenance of heavy equipments is already exhausted due to continuous implementation of various infrastructure projects for this year 2011;

WHEREAS, there is an available funding from the savings of various positions that can be reverted as additional funding for the repair and maintenance of heavy equipments, as well as fuel expenses in the said operation.

WHEREFORE, on motion by Hon. Merlou A. Dela Peña, severally seconded, be it

RESOLVE, to revert as it is hereby reverted, to ordain as it is hereby ordained:

APPROPRIATION ORDINANCE NO. 11-0307

Section 1. This Appropriation ordinance shall be entitled "Reversion of Appropriation".

Section 2. Sources of appropriation shall be taken from the savings of MAA II and RCC I from January to May, 2011 amounting One Hundred Fifty Three Thousand Three Hundred Sixty One and Five Centavos (P153,361.05).

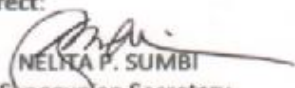
Section 3. The total amount shall be reverted for fuel expenses, repair and maintenance of heavy equipments for the repair and rehabilitation of barangay roads in the different barangays of San Pablo, Zamboanga del Sur.

Section 3. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.

ENACTED AND APPROVED on this 30th day of March 2011, during the 22nd Regular session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.

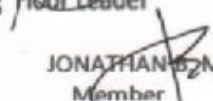
