RESOLVE, to revert as it is hereby reverted, to ordain as it is hereby ordained:

APPROPRIATION ORDINANCE NO, 11-0307

- Section 1. This Appropriation ordinance shall be entitled "Reversion of Appropriation".
- Section 2. Sources of appropriation shall be taken from the savings of MAA II and RCC I from January to May, 2011 amounting One Hundred Fifty Three Thousand Three Hundred Sixty One and Five Centavos (P153,361.05).
- Section 3. The total amount shall be reverted for fuel expenses, repair and maintenance of heavy equipments for the repair and rehabilitation of barangay roads in the different barangays of San Pablo, Zamboanga del Sur.
- Section 3. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.
