## APPROPRIATION ORDINANCE NO. 11-0308

- Section 1. This Appropriation ordinance shall be entitled "Reversion of Appropriation".
- Section 2. Sources of appropriation shall be taken from the savings of Municipal Technologist I for the month of January, 2011 amounting Twenty Thousand Seven Hundred Twenty Pesos and Seventy Eight Centavos (P20,720.78).
- Section 3. Out from the total savings, the amount of Fourteen Thousand Pesos (P14,000.00) shall be reverted for Honoraria of MS. ELVIE DE ASIS, Medical Technologist II (RHTPP) assigned at San Pablo, Zamboanga del Sur starting September, 2010 to March, 2011 at the rate of Two Thousand Pesos (P2,000.00) per month.
- Section 4. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.
