EXCERPT FROM THE MINUTES OF THE 22ND REGULAR SESSION OF THE 7TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE SESSION HALL ON MARCH 30, 2011.

RESOLUTION NO. 201103090

WHEREAS, there is a savings from the vacant position of Medical Technologist I for the month of January, 2011 amounting Twenty Thousand Seven Hundred Twenty Pesos and Seventy Eight Centavos (P20,720.78) as jointly certified by the Municipal Accountant Designate, the Municipal Treasurer and the Municipal Mayor respectively;

WHEREAS, the Department of Health (DOH) in its mandate to provide and appropriate health human resource in marginalized areas in need, recommends Ms. Elvie De Asis which was accepted by the LGU thru Hon. Mayor Belman B. Mantos to serve in the municipality as part of the Rural Health Team Placement Program (RHTPP) of the DOH.

WHEREFORE, on motion by Hon. Merlou A. Dela Peña, severally seconded, be it

RESOLVE, to revert as it is hereby reverted, to ordain as it is hereby ordained:

APPROPRIATION ORDINANCE NO. 11-0308

Section 1. This Appropriation ordinance shall be entitled "**Reversion of Appropriation**".

Section 2. Sources of appropriation shall be taken from the savings of **Municipal Technologist I for the month of January, 2011 amounting** Twenty Thousand Seven Hundred Twenty Pesos and Seventy Eight Centavos (P20,720.78).

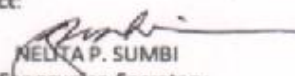
Section 3. Out from the total savings, the amount of Fourteen Thousand Pesos (P14,000.00) shall be reverted for Honoraria of **MS. ELVIE DE ASIS**, Medical Technologist II (RHTPP) assigned at San Pablo, Zamboanga del Sur starting September, 2010 to March, 2011 at the rate of Two Thousand Pesos (P2,000.00) per month.

Section 4. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.
