EXCERPT FROM THE MINUTES OF THE 22ND REGULAR SESSION OF THE 7TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE SESSION HALL ON MARCH 30, 2011.

RESOLUTION NO. 201103091

WHEREAS, the Municipal Officials of San Pablo, Zamboanga del Sur, thru the Honorable Mayor Belman B. Mantos manifested signify their willingness and intention to implement the Philippine Community eCenter (PhilCeC) Program in the municipality of San Pablo;

WHEREAS, there is an available funding from the savings of HRMO III from January to May, 2011 and from the position of Med-Tech I from February to April, 2011 amounting One Hundred Sixty Eight Thousand Nine Hundred Fifty Eight and Seventy Four Centavos (P168,958.74) that can be reverted for any necessary expenses;

WHEREFORE, on motion by Hon. Merlou A. Dela Peña, severally seconded, be it

RESOLVE, to revert as it is hereby reverted, to ordain as it is hereby ordained:

APPROPRIATION ORDINANCE NO. 11-0309

Section 1. This Appropriation ordinance shall be entitled "Reversion of Appropriation".

Section 2. Sources of appropriation shall be taken from the savings of HRMO II (January-May, 2011) and MED TECH I from January to April, 2011 amounting One Hundred Sixty Eight Thousand Nine Hundred Fifty Eight and Seventy Four Centavos (P168,958.74).

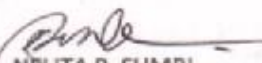
Section 3. The total amount shall be reverted for installation fee and other operating expenses relative to the implementation/establishment of the eCenter program.

Section 3. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.
