APPROPRIATION ORDINANCE NO, 11-0309

- Section 1. This Appropriation ordinance shall be entitled "Reversion of Appropriation".
- Section 2. Sources of appropriation shall be taken from the savings of HRMO II (January-May, 2011) and MED TECH I from January to April, 2011 amounting One Hundred Sixty Eight Thousand Nine Hundred Fifty Eight and Seventy Four Centavos (P168,958.74).
- Section 3. The total amount shall be reverted for installation fee and other operating expenses relative to the implementation/establishment of the eCenter program.
- Section 3. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.
