EXCERPT FROM THE MINUTES OF THE 25TH REGULAR SESSION OF THE 7TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE SESSION HALL ON MAY 25, 2011.

RESOLUTION NO. 201105103

WHEREAS, a joint certification was issued, certifying the total amount of Six Hundred Sixty Thousand Eight Hundred Ninety Six Pesos and Forty Centavos (P660,896.40) as the total amount of IRA difference for the months of January to March, 2011;

WHEREAS, said amount shall be utilized for the improvement of Rebi Scout Camp and Beach Resort, Indigency Fund and other expenses under the health services;

WHEREFORE, on motion by Hon. Merlou A. Dela Peña, severally seconded, be it

RESOLVE, to revert as it is hereby reverted, to ordain as it is hereby ordained:

APPROPRIATION ORDINANCE NO. 11-0511

Section 1. This Appropriation ordinance shall be entitled "Appropriation of funds".
