EXCERPT FROM THE MINUTES OF THE 57TH REGULAR SESSION OF THE 7TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE SESSION HALL ON AUGUST 29, 2012.

MUNICIPAL ORDINANCE NO. 2012-08229

"AN ORDINANCE CREATING THE MUNICIPAL BLOOD COUNCIL OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR.

WHEREAS, R.A. 7719 of the National Blood Services Act of 1994, otherwise known as "An Act Promoting Voluntary Blood Donation" which provide adequate supply of safe blood and the regulation of blood supply;

WHEREAS, the Department of Interior Local Government has since issued Memorandum Circular No. 96-06, dated 24 April 1996, mandating the Integration of the Voluntary Blood Donation Services and Program into the Local Financial work plan budget as an added function of the Local Health Board of LGU's:

WHEREAS, blood transfusion is a felt need of the community and is one of the basic services of the government must provide;

WHEREAS, it is a policy declaration of the State to promote and encourage blood donation by the citizenry and to instill public consciousness that blood donation is a social obligation and a humanitarian act;

WHEREAS, blood collection per barangay will ensure and guarantee sufficiency of supply to effectively respond to the needs of its constituents in ordinary and critical times.

NOW THEREFORE, BE IT ENACTED by the Sangguniang Baya of San Pablo, Province of Zamboanga del Sur in session assembled, that:

Section 1. Title – This ordinance shall be known and referred to as "AN ORDINANCE CREATING THE MUNICIPAL BLOOD COUNCIL OF THE MUNICIPALITY OF SAN PABLO, PROVINCE OF ZAMBOANGA DEL SUR".

Section 2. That the Municipal Blood Council of the municipality of San Pablo shall be created to institutionalize the provisions of the Republic Act 7719 otherwise known as the National Blood Services Act of 1994 and to fully implement DILG circular No. 96-06.

Section 3. That the Municipal Blood Council shall be composed of the Municipal Mayor as Chairman, Municipal Health Officer as Co-Chairman, Members: SB on Health, and various sectors of the community to be appointed by the Chairman.

Section 4. That the Barangay shall also create their own Barangay Blood Council to be headed by the Barangay Captain as Chairman, Kagawad on Health as Co-Chairman and 5 members which shall come from various sectors in the particular barangay to be appointed by the Chairman.

Section 5. That the Local Health Board shall be the policy-making body of the Municipal Blood Council. It shall constitute a committee to oversee and implement the Municipal Voluntary Blood Donation Program (MVBDP). It shall have the following functions:

- 1. Formulate the Municipal Voluntary Blood Donation Program (MVBDP) strategic plan;
- Operate the Barangay Blood Council in coordination with the respective barangay in the municipality.
- 3. Monitor and evaluate Municipal Voluntary Blood Donation Program (MVBDP).
- Incorporate into the strategic plan, programs such as but not limited to information and education, medical services, blood donor recruitment, retention and care, blood typing, blood collecting facilities, monitoring and evaluation.
- Indentify and train Barangay Coordinators who shall hence make operational the Barangay Blood Council.

Section 6. That all members of the Municipal Blood Council shall undergo training and orientation on the voluntary Blood Donation Program.

Section 7. That the Municipal Blood Council shall serve as the umbrella of all Blood Councils in the Municipality and shall have the following:

- Coordinate with the different blood councils related to blood program activities in the municipality;
- Source out and collect funds for the blood program (IEC materials, advocacy campaigns, trainings, seminars and conventions) from local and foreign donors;
- 3. Provide trainings/seminars on voluntary blood donation;
- 4. Monitor and evaluate different Barangay Councils in the municipality;
- 5. Assist the Barangay Blood Councils in identifying target groups for blood donations;
- Assist the Barangay Blood Councils in recruiting and screening (Physical examination, weight measurement, blood pressure, checking, hemoglobin determination and blood typing) of potential blood donors;
- 7. Assist the blood service facilities during the conduct of Barangay Blood donations;
- Assist the Barangay Blood Councils in the conduct of pre and post-donation counseling (donor retention, care and recall);
- 9. Document and maintain record of blood activities conducted.

Section 8. That the amount of ONE HUNDRED THOUSAND PESOS (P100,000.00) shall be appropriated to cover the production of IEC materials, trainings, seminars, monitoring and supplies needed by the Municipal Blood Council and other such paraphernalia in the conduct of blood donation.

Section 9. SEPARABILITY CLAUSE. If for any reason, any section or provision of this ordinance is declared unconstitutional or invalid, the other sections or provisions hereof which are not affected thereby shall continue to be in force and in effect.

Section 10. REPEALING CLAUSE. All ordinance, local issuance or rules inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 11. EFFECTIVITY. This ordinance shall take effect upon its approval.
