RESOLUTION NO. 201202173

WHEREAS, request for appropriation of funds for the monetization of leave credits at the office of the Sangguniang Bayan and Municipal Budget was submitted for favorable action;

WHEREAS, a joint certification was also submitted, certifying the total amount of Fifty Thousand Pesos (P50,000.00) as available source for appropriation.

WHEREFORE, on motion by Hon. Merlou A. Dela Peña, severally seconded, be it,

RESOLVED TO APPROPRIATE, as it is hereby appropriated, to ordain, as it is hereby ordained:

APPROPRIATION ORDINANCE NO. 12-0202

Section 1. This Appropriation ordinance shall be entitled "Appropriation of Funds".

Section 2. Sources of appropriation shall be taken from the following:

Savings from vacant positions:

HRMO III (January, 2012)	P20,847.40
Mod Toeh (January, 2012)	<u>30,105.00</u>
Total Savings from vacant positions	P50,952.40

Section 3. The total amount of Fifty Thousand Pesos (P50,000.00) shall be appropriated for monetization of leave credits of Hon. Jeffroy P. Cordero and Mrs. Vilma Cabunitas at the office of the Sangguniang Bayan and Municipal Budget, respectively.

Section 4. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.

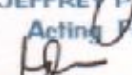

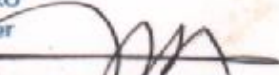

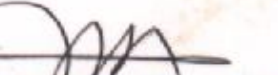
