RESOLUTION NO. 20140264

WHEREAS, reversion of appropriation was presented by the Hon. Vice Mayor Danilo Taucan to the Body for appropriate action;

WHEREAS, the total amount of One Hundred Twenty One Thousand Pesos (P121,000.00) shall be reverted from the appropriation for Terminal Leave under the office of the Local Chief Executive to travel of the same office.

WHEREFORE, on motion by Hon. Jorge R. Gonzales, duly seconded by Hon. Jeffrey P. Cordero, be it

RESOLVED, to revert, as it is hereby reverted, to ordain as it is hereby ordained:

APPROPRIATION ORDINANCE NO. 2014-0201

Section 1. This Appropriation ordinance shall be entitled "Reversion of Appropriation".

Section 2. Sources of funds shall be taken from the Appropriation for Terminal Leave Benefits of the Local Chief Executive Office.

Section 3. The total amount of One Hundred Twenty One Thousand Pesos (P121,000.00) shall be reverted as additional funds under the office of the Local Chief Executive appropriation for travelling expenses.

Section 4. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.
