EXCERPT FROM THE MINUTES OF THE 13TH REGULAR SESSION OF THE 9TH MUNICIPAL COUNCIL (Under the Local Government Code of 1991) HELD AT THE OFFICE OF THE MUNICIPAL VICE MAYOR, SAN PABLO, ZAMBOANGA DEL SUR ON DECEMBER 14, 2016.

ORDINANCE NO. 2016-1251

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWENTY EIGHT THOUSAND PESOS (P28,000.00) FROM THE APPROPRIATION FOR TELEPHONE EXPENSES, PRINTING AND BINDING AND POSTAGE AND DELIVERIES UNDER THE OFFICE OF THE SANGGUNIANG BAYAN TO TRAVELLING EXPENSES OF THE SAME OFFICE.."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Telephone Expenses, Printing and Binding and Postage and Deliveries under the office of the Sangguniang Bayan, San Pablo, Zamboanga del Sur;

Section 2. Out from the total appropriation, the amount of Ten Thousand Forty Two Pesos (P10,042.00) shall be augmented to the appropriation for Office Supplies, Other Supplies and Repair and Maintenance of IT Equipment of the same Office as follows:

From	To	Amount
1. Telephone Expenses	Travel	21,000.00
2. Printing and Binding		5,000.00
3. Postage and Deliveries		2,000.00
Total		P28,000.00

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

ENACTED AND APPROVED on this 14TH day of December, 2016, during the 13th Regular session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
