ORDINANCE NO. 20160812

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF SIXTY THREE THOUSAND PESOS (P63,000.00) FROM THE APPROPRIATION FOR OFFICE SUPPLIES AND TRAVELLING EXPENSES OF THE LOCAL CHIEF EXECUTIVE OFFICE TO OTHER MOOE OF THE SAME OFFICE AND TRAVELLING EXPENSES OF THE SB OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is hereby appropriated, travelling Expenses and Office Supplies under the office of the Local Chief Executive, San Pablo, Zamboanga del Sur;

Section 2. the following amount shall be transferred/augmented as follows:

FROM	Amount	TO	AMOUNT
1. Office Supplies	P28,000.00	Travel, SB Office	P23,000.00
2. Travel	35,000.00	Other MOOE	40,000.00
Total	P63,000.00		P63,000.00

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

ENACTED AND APPROVED on this 10TH day of August, 2016, during the 4TH Regular session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
