ORDINANCE NO. 20160820

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF ONE MILLION TWO HUNDRED TWENTY EIGHT THOUSAND TWO HUNDRED FIFTY PESOS (P1,228,250.00) FROM THE APPROPRIATION FOR SPORTS DEVELOPMENT PROGRAM AND REPAIR AND MAINTENANCE OF HEAVY EQUIPMENTS TO OTHER MAINTENANCE AND OPERATING EXPENSES OF ARAW NG SAN PABLO 2016."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is hereby appropriated Sports Development Program and Repair and Maintenance of Heavy Equipment in the general Fund for CY 2016 budget of San Pablo, Zamboanga del Sur;

Section 2. Out from the total appropriation, the following amount shall be transferred / augmented as follows:

Section 4. Transfer/Augment of Item. The Local Chief Executive of the Presiding officer of the Sanggunian concerned, May by ordinance, be authorized to augment any item in the

approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 5. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

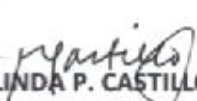

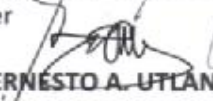
