Appropriation Ordinance no. 2016-0911

Section 2. Sources of appropriation shall be taken from the Terminal Leave Benefit For FY 2016 under the office of the Municipal Mayor, San Pablo, Zamboanga del Sur.

Section 3. The total amount shall be appropriated for the following:

1. Executive – Legislative Agenda (ELA)	P 179,000.00
2. Strategies Performance Management System (SPMS)	79,454.00
TOTAL SUPPLEMENTAL APPROPRIATIONS	<u>P 259,254.00</u>

Section 4. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.
