EXCERPT FROM THE MINUTES OF THE 1ST SPECIAL SESSION OF THE 9TH MUNICIPAL COUNCIL (Under the Local Government Code of 1991) HELD AT THE OFFICE OF THE MUNICIPAL VICE MAYOR, SAN PABLO, ZAMBOANGA DEL SUR ON NOVEMBER 29, 2016.

RESOLUTION NO. 20161144

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF THIRTY THOUSAND THREE HUNDRED SEVENTY PESOS (P30,370.00) FROM THE APPROPRIATION FOR INSURANCE EXPENSES, IT EQUIPMENT, OFFICE EQUIPMENT AND POSTAGE AND DELIVERIES UNDER THE OFFICE OF MUNICIPAL MAYOR, SAN PABLO, ZAMBOANGA DEL SUR TO OTHER MAINTENANCE AND OTHER OPERATING EXPENSES (OMOOE) OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Insurance Expenses, IT Equipment, Office Equipment, and Postage and Deliveries under the office of the Municipal Mayor, San Pablo, Zamboanga del Sur for FY 2016;

Section 2. The following amount shall be transferred/augmented as follows:

FROM	TO	AMOUNT
1. Insurance Expenses	Other MOOE (same office)	9,600.00
2. IT Equipment		13,270.00
3. Office Equipment		4,500.00
4. Postage and Deliveries		3,000.00

Section 3. Transfer/Augmentation of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

ENACTED AND APPROVED on this 29TH day of November, 2016, during the 1ST Special session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.

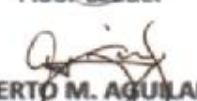
