MAYOR, SAN PABLO, ZAMBOANGA DEL SUR ON AUGUST 23, 2017.

ORDINANCE NO. 201708103

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWO HUNDRED
THOUSAND PESOS (P200,000.00) FROM THE APPROPRIATION FOR SPORTS DEVELOPMENT
UNDER THE OFFICE OF THE MUNICIPAL MAYOR TO THE APPROPRIATION FOR ARAW NG SAN
PABLO, 2017 OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN
SESSION ASSEMBLED:

Section 1. There is an appropriation for Araw Ng San Pablo, 2017 amounting **One Million Five
Hundred Thousand Pesos (P1,500.00)** in the General Fund Annual Budget for CY 2017
under the office of the Municipal Mayor, San Pablo, Zamboanga del Sur;

Section 2. The total amount of **Two Hundred Thousand Pesos (P200,000.00)** from the
appropriation for Sports Development shall be transferred/augmented to the
appropriation for Araw Ng San Pablo, 2017 of the same office to meet the minimum
funding requirement of **One Million Seven Hundred Thousand Pesos (P1,700,000.00)** as
presented in the Activity Profile submitted by the Local Chief Executive.

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the
Sanggunian concerned, may by ordinance, be authorized to augment any item in the
approved annual budget for their respective offices from savings in other items within
the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the
Sangguniang Bayan.

ENACTED AND APPROVED on this 23RD day of August, 2017, during the 37TH Regular
Session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del
Sur.
