## ORDINANCE NO. 2018-11211

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT TWO HUNDRED THIRTEEN THOUSAND SEVEN HUNDRED PESOS (P213,700.00) FROM THE DIFFERENT ITEMS UNDER TE OFFICE OF THE MUNICIPAL MAYOR TO AUGMENT APPROPRIATION FOR ELECTRIC BILLS OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation Balance of Ty/() Hundred Thirteen Thousand Seven Hundred Pesos under the office of the Municipal Mayor, San Pablo, Zamboanga del Sur from the following items:

- Section 2. the whole amount shall be augmented to the appropriation for Electric bills of the same office;
- Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).
- Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
