ORDINANCE NO. 2018-11213

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FIFTY THOUSAND PESOS FROM DIFFERENT APPROPRIATIONS TO TRAVELLING EXPENSES AND TELEPHONE EXPENSES UNDER THE OFFICE OF THE SANGGUNIAN SECRETARY, SAN PABLO, ZAMBOANGA DEL SUR."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Repair and Maintenance-Office Equipment; Repair and Maintenance - IT Equipment & Software; Other Maintenance and Operating expenses; Printing and Binding Expenses under the office of the Sanggunian Secretary, San Pablo, Zamboanga del Sur for CY 2018;

Section 2. The total amount to be transferred are as follows:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
