EXCERPT FROM THE MINUTES OF THE 60TH REGULAR SESSION OF THE 9TH MUNICIPAL COUNCIL (Under the Local Government Code of 1991) HELD AT THE ABC SESSION HALL, SAN PABLO, ZAMBOANGA DEL SUR ON MAY 23, 2018.

RESOLUTION NO. 201805175

WHEREAS, request for improvement of water system of the eight barangays in San Pablo, Zamboanga del Sur was submitted for appropriate action;

WHEREAS, a joint certification was issued, certifying the total amount of Four Hundred Forty Eight Thousand Eighty Two Pesos and Eighty Five Centavos (P448,082.85) as the total unutilized local counterpart (LGU & Barangays) for the SALINTUBIG projects;

WHEREFORE, on motion by Hon. Erlinda P. Castillo, duly seconded by Hon. Ernesto A. Utlang, be it

RESOLVED, to appropriate, as it is hereby appropriated, to ordain as it is hereby ordained;

APPROPRIATION ORDINANCE NO. 2018-0575

Section 1. This Appropriation Ordinance shall be entitled "Unutilized Local Counterpart (LGU & Barangays) for the SALINTUBIG project."

Section 2. Sources of appropriation shall be taken from the **COUNTERPART FUND OF THE SALINTUBIG PROJECT** amounting Four Hundred Forty Eight Thousand Eighty Two Pesos and Eighty Five Centavos (P448,082.85).

Section 3. The total amount of Four Hundred Forty Eight Thousand Eighty Two Pesos and Eighty Five Centavos (P448,082.85) shall be utilized for improvement of water system at Barangay Bubual-Ticala, Sacbulan, Tubo-pait, San Juan and Kalilangan, improvement of water system level II at barangay Buton; and Rehabilitation/Repair of Water System Level II at barangay Bag-ong Misamis.

Section 4. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.

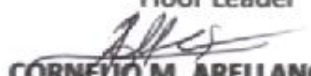
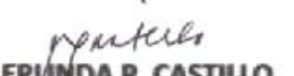
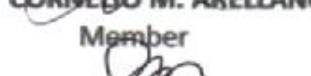
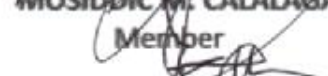
