## APPROPRIATION ORDINANCE NO. 2018-0677

- Section 1. Out from the total amount of One Million Twenty Eight Thousand Nine Hundred Sixteen Pesos and Sixty Two Centavos (P1,028,916.62) as the total PS savings from the different vacant positions, the total amount of Three Hundred Fifty Thousand Pesos (P350,000.00) shall be appropriated for the expenses of the Team Building and Capability Development Seminar on June 28, 2018 to July 2, 2018 at Davao City.
- Section 2. The total amount shall be used for Food Expenses, Accommodation, transportation and Fuel and for Resource Speakers.
- Section 3. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.
