## ORDINANCE NO. 2019-0701

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00) FROM THE APPROPRIATION FOR TERMINAL LEAVE EXPENSES UNDER THE OFFICE OF THE MUNICIPAL BUDGET OFFICER TO MONETIZATION OF LEAVE CREDITS OF MRS. JOSEPHINE R. BACON. LRCO II OFFICE OF THE MUNICIPAL TREASURER, SAN PABLO, ZAMBOANGA DEL SUR."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

- Section 1. There is hereby appropriated, TERMINAL LEAVE BENEFITS under the Office of the Municipal Budget Officer, San Pablo, Zamboanga del Sur for CY 2019;
- Section 2. Out from the total amount of Seven Hundred Twenty Nine Thousand Eight Hundred Eighty Nine Pesos and Eighty One Centavos (P729,889.81) the total amount of One Hundred Thousand Pesos (P100,000.00) shall be augmented to the appropriation for Monetization of Leave Credits of Mrs. Josephine R. Bacon, LRCO II under the office of the Municipal Treasurer, San Pablo, Zamboanga del Sur.
- Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).
- Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

ENACTED AND APPROVED on this 10<sup>TH</sup> day of July, 2019, during the 1<sup>ST</sup> Regular session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
