

ORDINANCE NO. 2020-0507

"AN ORDINANCE STRICTLY IMPOSING MEASURES TO PREVENT THE SPREAD OF CORONA VIRUS DISEASE 2019 (COVID 19) AND OTHER EMERGING INFECTIOUS DISEASES IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR AND FOR OTHER PURPOSES, PROVIDING PENALTIES FOR VIOLATION THEREOF".

Be it ordained by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, in session assembled that:

- Section 1. Title. This shall be known as "An Ordinance Strictly Imposing Measures to stem the transmission of Corona Virus Disease (COVID 19) and other Emerging Diseases in the municipality of San Pablo, Zamboanga del Sur."
- Section 2. Scope. This ordinance shall cover all residents and transients in all barangays in the entire municipality of San Pablo, Zamboanga del Sur.
- Section 3. Definition of Terms. As used in this Ordinance., the following terms shall mean:
 - Emerging Infectious Disease An infectious disease that has newly appeared in a population or that has been known for some time but is rapidly increasing in incidence or grographip range;
 - Face mask a protective mask or other equipment covering the nose and mouth or nose and eyes, such as indigenous, reusable, homemade, do-it-yourself masks, face shields, handkerchiefs, and the like;
 - Holding area a designated place where the violators shall be held for counselling and to correct disobedience;
 - d. Home Quarantine Pass a pass issued to one person per household giving access to him/her to leave their residence solely for purposes of buying food, medicines and other basic necessities and health services;
 - e. Person human being regarded as individual, regardless of age and gender; and
 - Transient a person who is staying or working in a place for only a short time.
- Section 4. Regulated Acts. To prevent the spread of Corona Virus Disease 2019 in the mun. of San Pablo, Zamboanga del Sur, the following measures shall be strictly imposed:
 - a. A person whenever allowed to go out of his/her residence shall wear face mask at all times.
 - b. All persons in public places shall observed social (physical) distancing by being one meter apart from each other.
 - c. The person designated by his/her household to be issued the Home Quarantine Pass (HQP) shall use it on the days as may be prescribed and solely for the purpose it is intended. Any person is prohibited to leave his/her residence without the HQP.
 - d. All mass gatherings are deterred. Any person organizing such gathering shall be held accountable.
 - e. Mass public ransport is suspended, however, vehicles may be used by a person issued the HQP to access basic necessities or health services.
 - f. Consumption of intoxicating liquor or alcohol beverage in public shall be prohibited. Selling, furnishing, buying, serving, and dispensing thereof shall likewise be prohibited.

- Section 5. Implementing Guidelines. The Inter-Agency Task Force created by the Municipal Mayor through Executive Order, shall issue the implementing guidelines for this ordinance.
- Section 6. Penalty Clause. Any person who violates any of the provisions of this ordinance shall be penalized as follows:
 - 5.1 High Risk Population ages 0-20 years old must remain at home. Persons with are ranging from 21 years old but below 60 years old with comorbidities or other risk factors.

First offense - A Fine of Five Hundred Pesos (P500.00) and two (2) hours community service.

Second offense - A Fine of One Thousand Pesos (P1,000.00) or imprisonment of One (1) day, or fine and imprisonment at the discretion of the court.

<u>Third offense</u> - A Fine of Two Thousand Pesos (P2,000.00) or imprisonment of One (2) days, or fine and imprisonment at the discretion of the court.

5.2 Pursuant to DILG MC 2020-071 All persons are enjoined to wear Face masks or other protective equipment in all public areas.

First offense - A Fine of Five Hundred Pesos (P500.00) and two (2) hours community service.

Second offense - A Fine of One Thousand Pesos (P1,000.00) or imprisonment of One (1) day, or fine and imprisonment at the discretion of the court.

<u>Third offense</u> - A Fine of Two Thousand Pesos (P2,000.00) or imprisonment of One (2) days, or fine and imprisonment at the discretion of the court.

5.3 Strict Physical Distancing/Social Distancing shall be observed at all times even in private and Public Transport Vehicles

First offense - A Fine of Five Hundred Pesos (P500.00) and two (2) hours community service.

Second offense - A Fine of One Thousand Pesos (P1,000.00) or imprisonment of One (1) day, or fine and imprisonment at the discretion of the court.

<u>Third offense</u> - A Fine of Two Thousand Pesos (P2,000.00) or imprisonment of One (2) days, or fine and imprisonment at the discretion of the court.

5.4 For organizing mass gathering and consuming, selling, furnishing, buying, serving and dispensing of alcoholic beverages and intoxicating liquor.

First offense - A Fine of Five Hundred Pesos (P500.00) and two (2) hours community service.

Second offense - A Fine of One Thousand Pesos (P1,000.00) or imprisonment of One (1) day, or fine and imprisonment at the discretion of the court.

<u>Third offense</u> - A Fine of Two Thousand Pesos (P2,000.00) or imprisonment of One (2) days, or fine and imprisonment at the discretion of the court.

5.5 School, amusement centers, leisure facilities, gaming, tourism services, and other establishments that are continued to be closed.

First offense - A Fine of Five Hundred Pesos (P500.00) and two (2) hours community service.

Second offense - A Fine of One Thousand Pesos (P1,000.00) of imprisonment of One (1) day, or fine and imprisonment at the discretion of the court.

<u>Third offense</u> - A Fine of Two Thousand Pesos (P2,000.00) or imprisonment of One (2) days, or fine and imprisonment at the discretion of the court.

5.6 Curfew.

First offense - A Fine of Five Hundred Pesos (P500.00) and two (2) hours community service.

Second offense - A Fine of One Thousand Pesos (P1,000.00) or imprisonment of One (1) day, or fine and imprisonment at the discretion of the court.

<u>Third offense</u> - A Fine of Two Thousand Pesos (P2,000.00) or imprisonment of One (2) days, or fine and imprisonment at the discretion of the court.

3.7 For abuse of the use of Home Quarantine Pass

First offense - A Fine of Five Hundred Pesos (P500.00) and two (2) hours community service.

Second offense - A Fine of One Thousand Pesos (P1,000.00) or imprisonment of One (1) day, or fine and imprisonment at the discretion of the court.

<u>Third offense</u> - A Fine of Two Thousand Pesos (P2,000.00) or imprisonment of One (2) days, or fine and imprisonment at the discretion of the court.

- Section 7. Separability Clause. Should any provision/s of this ordinance be declared invalid or unconstitutional by a competent authority, parts that are not affected shall remain in full force and effect.
- Section 8. Effectivity. This ordinance shall take effect upon its approval and posting in at least three other conspicuous places in the municipality, whichever comes later.
