ORDINANCE NO. 2020-0508

AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF THIRTEEN THOUSAND PESOS (P13,000.00) FROM THE APPROPRIATION FOR OFFICE SUPPLIES AND REPAIR AND MAINTENANCE –IT EQUIPMENT TO TRAVELLING EXPENSES UNDER THE OFFICE OF THE MUNICIPAL CIVIL REGISTRAR, SAN PABLO, ZAMBOANGA DEL SUR.”

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Office Supplies amounting Six Thousand Pesos (P6,000.00) and Repair and Maintenance – IT Equipment amounting Seven Thousand Pesos (P7,000.00) a total of Thirteen Thousand Pesos (P13,000.00), balance for CY 2020, under the office of the Municipal Civil Registrar, San Pablo, Zamboanga del Sur;

Section 2. The total amount of **Thirteen Thousand Pesos (P13,000.00)** is hereby transferred to augment appropriation for travelling Expenses under MCR Office.

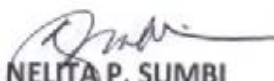
Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

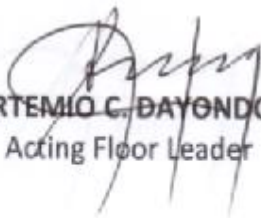
