ORDINANCE NO. 2020-0710

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FORTY THOUSAND THREE HUNDRED NINETY NINE PESOS (P40,399.00) FROM THE APPROPRIATION FOR OTHER SUPPLIES UNDER THE OFFICE OF THE MUNICIPAL MAYOR TO PURCHASE OF MATERIALS AND LABOR EXPENSES FOR WALLING OF PLUMBING/WATERWORKS AND MARKET OFFICE, SAN PABLO, ZAMBOANGA DEL SUR."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

- Section 1. There is an appropriation for Other Supplies amounting Forty Thousand Three Hundred Ninety Nine Pesos (P40,399.00), under the office of the Municipal Mayor, San Pablo, Zamboanga del Sur;
- Section 2. The total amount is hereby transferred to augment appropriation for Walling Expenses under Plumbing/Water Works and Market office.
- Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).
- Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
