ORDINANCE NO. 2020-0714

"AN ORDINANCE TRANSFERRING THE POSITION OF COMPUTER OPERATOR II, ITEM NO. 32, SG 9/6 UNDER THE OFFICE OF THE SANGGUNIANG BAYAN TO THE OFFICE OF THE MUNICIPAL CIVIL REGISTRAR, SAN PABLO, ZAMBOANGA DEL SUR."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR, IN SESSION ASSEMBLED:

Section 1. The Position of Computer Operator II item 32, SG 9/6 under the office of the Sangguniang Bayan was created and filled up by Mrs. Gemma Capitanea few years ago but considered vacant since said employee was reassigned to the office of the Municipal Civil Registrar;

Section 2. The item and funding of the said position be transferred to the Office of the Municipal Civil Registrar, with the same employee, duties and functions and benefits as the employee is usually receiving.

Section 3. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.

Section 4- This Ordinance shall take effect immediately upon its approval;
