ORDINANCE NO. 2020-0720

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF ONE HUNDRED TWENTY FOUR THOUSAND SEVEN HUNDRED SEVENTY NINE PESOS (P124,779.00) FROM THE APPROPRIATION FOR OTHER MOOE AND EQUIPMENT/FURNITURE OUTLAY TO MOOE AND CAPITAL OUTLAY UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER, SAN PABLO, ZAMBOANGA DEL SUR."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Other MOOE and Equipment/Furniture Outlay under the office of the Municipal Health Officer (MHO), San Pablo, Zamboanga del Sur amounting One Hundred Twenty Four Thousand Seven Hundred Seventy Nine Pesos (P124,779.00);

Section 2. The following amount shall be transferred to wit:

	Repair & Maintenance-Artesian Wells, reservoir, pumping station and conduit	P18,186.00
Equipment/Furniture Outlay	Water Supply System	P75,000.00

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

ENACTED AND APPROVED on this 29th day of July, 2020, during the 20TH Regular session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.

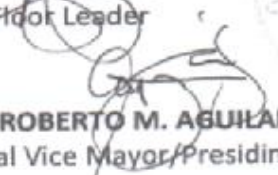
