**"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF ONE HUNDRED EIGHTY THOUSAND PESOS (P180,000.00) FROM THE APPROPRIATION FOR CONSULTANCY SERVICES, OTHER MAINTENANCE AND OTHER OPERATING EXPENSES, AND COUNTERPART FUND FOR RED CROSS UNDER THE OFFICE OF THE MUNICIPAL MAYOR, SAN PABLO, ZAMBOANGA DEL SUR, TO THE APPROPRIATION FOR OTHER SUPPLIES, TELEPHONE EXPENSES AND ASSISTANCE TO INDIVIDUAL IN CRISIS SITUATION OF THE SAME OFFICE."**

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:**

**Section 1.** There is an appropriation for Consultancy Services, Other Maintenance and Other Operating Expenses, and Counterpart fund for Red Cross, under the office of the Municipal Mayor, San Pablo, Zamboanga del Sur, amounting **One Hundred Ninety Eight Thousand Three Hundred Ninety Pesos and Thirty Six Centavos (P198,390.36);**

**Section 2.** The following amount shall be transferred to wit:

**Section 3.** Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

**Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
