EXCERPT FROM THE MINUTES OF THE 32ND REGULAR SESSION OF THE 10TH MUNICIPAL COUNCIL (Under the Local Government Code of 1991) HELD AT THE OFFICE OF THE MUNICIPAL VICE MAYOR, SAN PABLO, ZAMBOANGA DEL SUR ON OCTOBER 21, 2020.

ORDINANCE NO. 2020-1034

"AN ORDINANCE FIXING FEES FOR RAPID DIAGNOSTIC TEST (RDT) TO BE CONDUCTED IN THE MUNICIPAL HEALTH OFFICE (MHO) OF SAN PABLO, ZAMBOANGA DEL SUR."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. Purpose. Sec. 447, par. 3 (i) of the Local Government Code of 1991 authorize the Legislative body to fix and impose charges for all services rendered by the Municipal Government to private persons or entities, and Sec. 153 stipulates that the LGUs may collect reasonable fees and charges for services rendered.

The regulation of business and activities as the delivery of services to the people through the LGU entails costs to the government, and equity requires that person/s benefiting from the services to share the costs of providing such services.

Section 2. Scope. San Pablohanons (Resident-non indigent and for Resident-Indigent) seeking medical services from our Rural Health Center, hence this ordinance aims to include non-San Pablohanons who preferred to be examined and checked by our Municipal Health Officer, and for non-4P's members or non- LSI and non-San Pablohanons to avail the rapid diagnostic test in the Municipal Health Office.

Section 3. Definition of Terms. The terms for the purpose of this ordinance shall mean:

- Non-San Pablohanons – refer to any person who is not registered as voters in the municipality of San Pablo.
- Rapid Diagnostic Test – is a medical diagnostic test that is quick and easy to perform. RTDs are suitable for preliminary or emergency medical screening and for use in medical facilities with limited resources.
- Locally Stranded Individuals – refer to foreign nationals or Filipino citizens in a specific locality within the Philippines who have expressed intention to return to their place of residence/home origin. LSI's can be further classified into: workers, students, tourist and other individuals stranded in various localities while in transit.
- Non-4Ps Member – refers to an individual who is not a registered member or a grantee of the privilege provided for on the Pantawid Pamilyang Pilipino Program (4Ps).

Section 4. Fees. The amount of One Thousand Two Hundred Fifty Pesos (P1,250.00) shall be collected to the following persons for payment of the Rapid Diagnostic Test for COVID-19:

1. Undocumented travelers, and their contacts (e.g. drivers, conductors, relatives, neighbors, etc. who have substantial contact with the traveler.
2. Contacts of suspected, probable and confirmed case of COVID-19 patients.
3. All officials/personnel/constituents on personal travel.
4. Subsequent watchers.
5. Patients and significant others (e.g. relatives) for OPD consultation.

6. Patient for admission (and 1 watcher only) – based on the request of the referral hospital, free of charge, but subsequent watchers, patients and significant others (e.g. relatives) for OPD consultation will be charged for the cost of RDT.

In addition thereto, for non-LSI, non-4Ps member and non-San Pablohanons who wanted to be admitted in health Institutions but can not do so since they were required to present their rapid test result, then through this ordinance, they are allowed to avail the rapid diagnostic test in the Municipal Health Office upon payment of One Thousand Two Hundred Fifty Pesos (P1,250.00) to the Municipal Treasurer.

Section 5. Time of Payment. The fee shall be paid to the Municipal Treasurer before the physical examination/consultation or rapid diagnostic test is made.

Section 6. Separability Clause. If any reason, any provision, portion or part of this ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

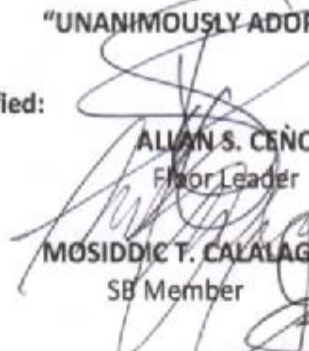
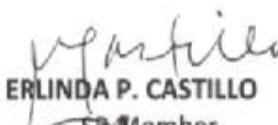
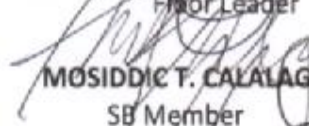
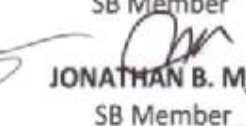
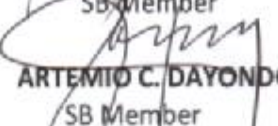
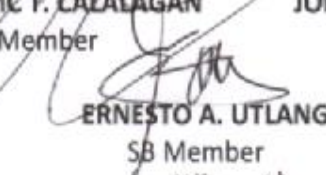
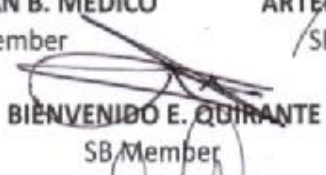
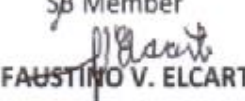
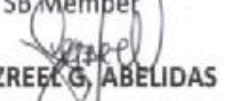
Section 7. Repealing/Amendatory Clause. All ordinances, and regulations or part/s thereof, which are inconsistent or in conflict with the provisions of this ordinance are hereby repealed, amended and or modified accordingly.

Section 8. Effectivity. This ordinance shall take effect immediately.
