APPROPRIATION ORDINANCE NO. 2020-1141

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. Title: This appropriation ordinance shall be entitled "Reversion of Appropriation"

Section 2. Source of Fund: General Fund Annual Budget for CY 2020:

1. Gender and Development (GAD) 2020	P 410,000.00
2. LDRRM (2020)	2,028,000.00
3. LCPC	<u>120,000.00</u>
Total	<u>P2,558,000.00</u>

Section 3. Appropriation: The total amount of Two Million Five Hundred Fifty Eight Thousand Pesos (P2,558,000.00) shall be reverted to Meals and Snacks for COVID-19 Isolation Facility and other COVID-19 related expenses.

Section 4. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.

Section 5. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
