ORDINANCE NO. 2020-1143

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FORTY THREE THOUSAND THREE HUNDRED FIFTY PESOS (P43,350.00) FROM THE APPROPRIATION FOR WIRELESS ACCESS FOR HEALTH (WAH) UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER TO OTHER SUPPLIES AND MATERIALS EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for *Special Program/Wireless Access for Health* under the office of the Municipal Health Officer, San Pablo, Zamboanga del Sur, amounting Forty Three Thousand Three Hundred Pesos (P43,350.00);

Section 2. The whole amount shall be transferred to the following:

<i>Special Program/Wireless Access for Health</i>	<i>Other Supplies and Materials</i>	<i>P43,350.00</i>

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

ENACTED and APPROVED this 11TH day of November, 2020, during the 35TH Regular session of the Honorable Sangguniang Bayan of San Pablo, Zamboanga del Sur.
