Section 1. Title: This appropriation ordinance shall be entitled "Reversion of Appropriation"

Section 2. Source of Fund: General Fund Annual Budget for CY 2020:

Section 3. Appropriation: The total amount of Two Million Forty Thousand Pesos (P2,040,000.00) shall
be reverted/Transferred to the following:

1. Procurement of Tables and Chairs for Rebi Beach Resort	P 500,000.00
2. Water System Maintenance for Rebi Beach Resort	300,000.00
3. Installation of Wireless Internet Connection for Rebi Beach Resort	100,000.00
4. Representation Expenses (Office of the Municipal Mayor)	400,000.00
5. Other Supplies, Office of the Municipal Mayor	385,000.00
6. Other Maintenance and Operating Expenses	105,000.00
7. Tourism Development Planning	<u>250,000.00</u>
Total	<u>P2,040,000.00</u>

Section 4. Amendments to this ordinance shall take effect only when subsequent ordinance shall be
enacted by the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur,
amending, supplementing, or repealing any part hereof in line with the established policies,
guidelines, laws, rules and regulations enforce.

Section 5. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang
Bayan.
