ORDINANCE NO. 2020-1250

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF SIXTY NINE THOUSAND EIGHT HUNDRED PESOS (P69,800.00) FROM THE APPROPRIATION FOR HIV & AIDS/STI AND TRAVELLING EXPENSES UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER TO OTHER MOOE, BLOOD DONATION PROGRAM, MEDICAL SUPPLIES AND OFFICE SUPPLIES & MATERIALS OF SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIAN BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for HIV & AIDS/STI Program amounting Fifty Two Thousand Pesos (P52,000.00) and appropriation for Travelling Expenses amounting Seventeen Thousand Eight Hundred Pesos (P17,800.00), a total of Sixty Nine Thousand Eight Hundred Pesos (P69,800.00) under the office of the Municipal Health Officer, San Pablo, Zamboanga del Sur for FY 2020;

Section 2. The Total amount shall be transferred/augmented for the following:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
