EXCERPT FROM THE MINUTES OF THE 4TH REGULAR SESSION OF THE 10TH MUNICIPAL COUNCIL (Under the Local Government Code of 1991) HELD AT THE OFFICE OF THE MUNICIPAL VICE MAYOR, SAN PABLO, ZAMBOANGA DEL SUR ON FEBRUARY 12, 2020.

RESOLUTION NO. 20200202

"AN ORDINANCE AUTHORIZING PAYMENT OF HONORARIUM TO OFFICIALS AND EMPLOYEES OF THE NATIONAL AGENCIES ASSIGNED IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."

Be it ordained by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, in session assembled that:

Section 1. Title. This ordinance shall be entitled "Honorary Fee"

Section 2. Section 16 of R. A. 7160 states that: The sangguniang bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants;

Section 3. Article 100 (xi) of R. A. 7160 states that: When the finances of the municipal government allow, provide for additional allowances and other benefits to judges, prosecutors, public elementary and high school teachers, and other national government officials stationed in or assigned to the municipality.

Section 4. Subject to Commission On Audit (COA) auditing rules and regulations, the LGU of San Pablo is providing Honorary fee of Seven Thousand Two Hundred Pesos (P7,200.00) and Six Thousand Pesos (P6,000.00) to qualified National Government Officials and Employees, assigned in the municipality, as incorporated in the General Fund Annual Budget for 2020.

Section 5. Effectivity. This ordinance shall take effect January 1, 2020.

ENACTED AND APPROVED on this 12TH day of February, 2020, during the 4TH Regular session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
