WHEREAS, joint certifications were issued by the Local Finance Committee, certifying the total amount of Five Hundred Ninety Two Thousand Two Hundred Thirty Pesos and Seventy Four Centavos (P592,230.74) as the total PS Savings from the different offices for the month of June, 2020.

WHEREAS, request for appropriation was submitted for priority programs and projects of the different offices;

WHEREAS; there is a need to expand the swimming pool at the Rebi Beach Resort as recommended by the MPDC and Municipal Engineer since it was not included in the Program of Work for rehabilitation;
