"A RESOLUTION ADOPTING RESOLUTION NO. 3-2020 OF THE OFFICE OF MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN, RE: A RESOLUTION TRANSFERRING THE APPROPRIATION FOR PROVISION OF LEARNING MATERIALS AND TOILETRIES TO INDIGENT CHILDREN AMOUNTING SIXTY THOUSAND PESOS (P60,000.00) TO PURCHASE OF 3 N 1 PHOTOCOPIER, PRINTER AND SCANNER FOR THE REPRODUCTION OF MODULE FOR THE DAY CARE PUPIL OF 28 BARANGAYS."
