Maintenance and Other Operating Expenses

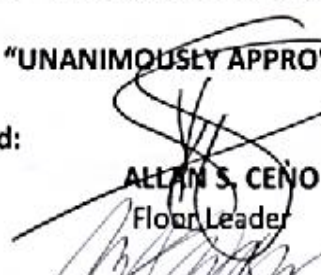

TOTAL SUPPLEMENTAL APPROPRIATIONS	<u>P 579,427.74</u>

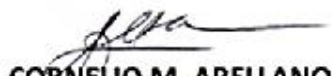
