RESOLUTION NO. 20201052

"A RESOLUTION AUTHORIZING HON. MAYOR DANILO A. TAUCAN OF SAN PABLO, ZAMBOANGA DEL SUR TO ENTER INTO MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) FOR THE GRANT OF LOTTO/STL CHARITY FUND SHARE."

WHEREAS, aligned with President Rodrigo Roa Duterte's programs, the Philippine Charity Sweepstakes (PCSO), pursuant to its mandate, shall provide LGUs with portion of the charity fund generated from the sales of Lotto and STL within their jurisdiction, as share for LGUs to be used by them for their medical and health-related services;

WHEREAS, the PCSO, upon request of the LGU shall also grant Calamity Assistance, in a form of financial assistance to qualified beneficiaries or medical services, based on the Situational/Assessment report submitted, including data obtained from government agencies involved in the provision of services or assistance in times of calamity/disaster;

WHEREAS, one of the LGUs obligation is to acknowledge PCSOs contribution; ensure liability of the grant to the PCSO by adopting applicable government accounting and auditing rules; in case of calamity assistance, ensure that the assistance be utilized for feeding projects for displaced families in the evacuation center; procurement of food, water, sanitation, tents medicines and/or medical supplies necessary for the disease prevention and/or treatment among the affected population.

WHEREFORE, on motion by Hon. Erlinda P. Castillo, duly seconded by Hon. Jonathan B. Medico, be it

RESOLVED, as it is hereby resolved, authorizing Hon. Mayor Danilo A. Taucan of San Pablo, Zamboanga del Sur to enter into Memorandum of Agreement (MOA) with the Philippine Charity Sweepstakes (PCSO) for the grant of LOTTO/STL Charity Share.
