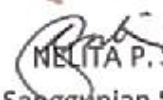

EXCERPT FROM THE MINUTES OF THE 49TH REGULAR SESSION OF THE 10TH MUNICIPAL COUNCIL (Under the Local Government Code of 1991) HELD AT THE OFFICE OF THE MUNICIPAL VICE MAYOR, SAN PABLO, ZAMBOANGA DEL SUR ON MARCH 10, 2021.

ORDINANCE NO. 2021-03-01

"AN ORDINANCE IMPOSING FEES AND CHARGES ON THE USE OF REBI BEACH RESORT'S FACILITIES AND AMENITIES AND REGULATING THE SAME."

BE IT ORDAINED BY THE SANGGUNINANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED.

Section 1. Pursuant to paragraph 3(1), art 100, rule XVII of the 1991 Local Government Code, the Sangguninang Bayan shall fix and impose reasonable fees and charges for all services rendered by the Municipal Government to private persons or entities and Art. 222 of the code states that "the power to impose a tax, fee or charge, or to generate revenue under the code shall be exercised by the Sanggunian of the LGU concerned through an appropriate tax ordinance or revenue measure."

Section 2. Any person who will enter the resort premises, shall be collected with an entrance fees of Forty Pesos (P40.00) for adult and Twenty Pesos (P20.00) for children below 10 years old.

Section 3. The payment of the entrance fees shall entitle anybody to use the swimming pools and beach resort.

Section 4. Group or individuals may use the cottages provided that they will pay the rent of Five Hundred pesos (P500.00) per cottage for big cottages and Four Hundred Pesos (P400.00) per cottage for small cottages from 6:00a.m to 6:00p.m. and an additional charge of One Hundred Pesos (P100.00) per cottage for an overnight stay.

Section 5. In case of shortage of cottages, a six-seater table shall be issued to customer with a minimum charge of Two Hundred Pesos (P200.00).

Section 6. Use of Executive Villa shall be charged One Thousand Five Hundred Pesos (P1,500.00) per day. Check in time is 2:00 p.m. and Check out time is 12:00 noon in the following day.

Section 7. The Resort Function Hall may be rented for group activities at Five Thousand Pesos (P5,000.00) per day.

Section 8. Resorters who will use the swimming pool should take a shower first.

Section 9. For Health reasons, person who are inflicted with skin diseases are prohibited to use the swimming pools.

Section 10. Resorters are advised to use Proper Swimming attire when using the swimming pool.

Section 11. To maintain health and sanitation, garbage and leftover should not be thrown to the sea but placed in a compartment provided for.

Section 12. Eating and Drinking Liquor in the swimming pool is strictly prohibited.

Section 13. The resort should not be used for initiation of any Fraternity or Sorority or any illegal activities.

Section 14. No vendors are allowed to sell any kind of foods and beverages inside the Resort's Premises.

Section 15. Reservation should be done in advance before the activity commences and upon payment of Fifty Percent (50%). Cancellation of reservation should be done Three (3) days before the schedule with a retention fee of 20%.

Section 16. Management of the Resort shall be done by the LGU's authorized representative and the office of the Municipal Treasurer.

Section 17. Exclusive use of the Resort shall be charged Fifty Thousand Pesos (P50,000.00)/24 hours.

Section 18. Repealing Clause. This ordinance amends Municipal Ordinance No. 2011-0708 particularly the title, and sections 2, 4, 5, 6, 7, 10, 14, 15, 16, 17 and 18.

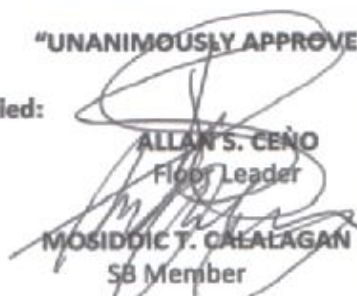
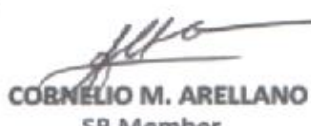
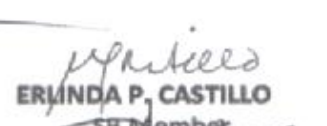
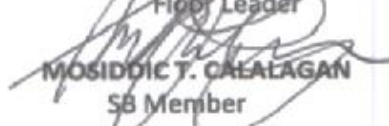
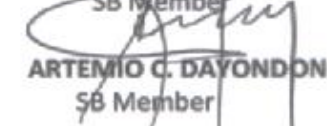
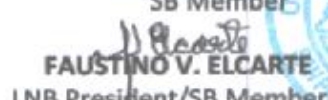
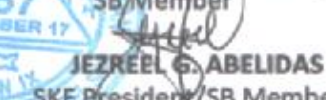
Section 19. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur.

Section 20. Effectivity. This ordinance shall take effect immediately after approval of the Municipal Mayor and 15 days after its third reading and posting in three (3) conspicuous places.

ENACTED AND APPROVED on this 10TH day of March, 2021, during the 49TH Regular Session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.

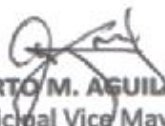

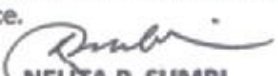
