APPROPRIATION ORDINANCE NO. 2021-04-002

"AN ORDINANCE TRANSFERRING THE TOTAL AMOUNT OF FIVE HUNDRED THOUSAND PESOS FROM CONTINUING APPROPRIATION - HEAVY EQUIPMENT LOAN REPAYMENT BALANCE 2020 FOR THE PROCUREMENT OF TABLES AND CHAIRS FOR REBI BEACH RESORT, SAN PABLO, ZAMBOANGA DEL SUR."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

- Section 1. There is an available amount of One Million Five Hundred Thirty Nine Thousand One Hundred Twelve Pesos and Thirty Four Centavos (P1,539,112.34) from Continuing Appropriation -Heavy Equipment Loan Repayment Balance 2020;
- Section 2. The Total amount of Five Hundred Thousand Pesos (P500,000.00) shall be transferred for the purchase of Tables and Chairs for Rebi Beach Resort, Teniapan, San Pablo, Zamboanga del Sur.
- Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).
- Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
