ORDINANCE NO. 2021-06-007

**"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWO MILLION ONE HUNDRED FIFTY FOUR THOUSAND EIGHT HUNDRED FORTY PESOS (P2,154,840.00) FROM THE APPROPRIATION FOR ARAW NG SAN PABLO; SPORTS AND DEVELOPMENT PROGRAM; REPAIR AND MAINTENANCE OF MOTOR VEHICLE AND INSURANCE EXPENSES MOTOR- VEHICLE UNDER THE OFFICE OF THE MUNICIPAL MAYOR TO COUNTERPART FUND OF KALAHY CIDSS ADDITIONAL FUNDING DISASTER RESPONSE OPERATION PROCEDURE (AF-DROP)."**

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:**

**Section 1.** There is an appropriation for Araw ng San Pablo amounting One Million Five Hundred Thousand Pesos (P1,500,000.00); Sports and Development Program amounting Six Hundred Thousand Pesos (P600,000.00); Repair and Maintenance of Motor Vehicle amounting Twenty Seven Thousand Four Hundred Twenty Pesos (P27,420.00) and Insurance of Motor Vehicle amounting Twenty Seven Thousand Four Hundred Twenty Pesos (P27,420.00) in the CY 2021 Annual Budget under the office of the Local Chief Executive;

**Section 2.** The total amount of Two Million One Hundred Fifty Four Thousand Eight Hundred Forty Pesos (P2,154,840.00) shall be transferred to counterpart fund for KALAHY-CIDSS Additional Funding Disaster Response Operation Procedure (AF-DROP) Program.

**Section 3.** Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

**Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
