APPROPRIATION ORDINANCE NO. 2021-09-021

"AN ORDINANCE TRANSFERRING/AUGMENTING THE AMOUNT OF TWENTY TWO THOUSAND PESOS (P22,000.00) FROM THE APPROPRIATION FOR OTHER SUPPLIES UNDER THE OFFICE OF THE MUNICIPAL MAYOR, LGU, SAN PABLO, ZAMBOANGA DEL SUR TO ELECTRICITY EXPENSES."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. This ordinance shall be called, **"TRANSFER OF FUNDS."**

Section 2. There is an amount appropriated for Other Supplies under the office of the Municipal Mayor, San Pablo, Zamboanga del Sur;

Section 3. The amount of Twenty Two Thousand Pesos (P22,000.00) shall be transferred to Electricity Expenses of the same office.

Section 4. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 5. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

ENACTED AND APPROVED on this 6TH day of October, 2021, during the 78TH Regular session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
