APPROPRIATION ORDINANCE NO. 2021-10-023

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF THIRTY SIX THOUSAND SIX HUNDRED PESOS (P36,600.00) FROM THE APPROPRIATION FOR REPAIR AND MAINTENANCE — OFFICE EQUIPMENT, REPAIR AND MAINTENANCE — IT EQUIPMENT AND OTHER MOOE UNDER THE OFFICE OF THE MUNICIPAL TREASURER TO TRAVELLING EXPENSES - LOCAL OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Repair and Maintenance – Office Equipment, Repair and Maintenance – It Equipment and Other MOOE under the Office of the Municipal Treasurer amounting Thirty Six Thousand Six Hundred Pesos (P36,600.00);

Section 2. The following amount are to be augmented:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
