APPROPRIATION ORDINANCE NO. 2021-12-032

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF ONE HUNDRED EIGHTY TWO THOUSAND PESOS (P182,000.00) FROM THE APPROPRIATION FOR CAPITAL OUTLAY – FENCES, COVERED WALKS & DRIVEWAYS TO PURCHASE OF IT EQUIPMENTS; OTHER MOOE TO REPAIR & MAINTENANCE – IT EQUIPMENTS, MEDICAL SUPPLIES AND SPECIAL PROGRAM / WIRELESS ACCESS FOR HEALTH UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER TO OFFICE SUPPLIES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Capital Outlay – Fences, Covered Walks & Driveways and other MOOE under the Office of the Municipal Health Officer amounting One Hundred Eighty Two Thousand Pesos (P182,000.00) ;

Section 2. The following amount are to be augmented:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

ENACTED AND APPROVED on this 22ND day of December, 2021, during the 89TH Regular session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
