APPROPRIATION ORDINANCE NO. 2021-12-035

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FIFTY THREE THOUSAND PESOS (P53,000.00) FROM THE APPROPRIATION FOR PRINTING & BINDING, POSTAGE & DELIVERIES, REPAIR AND MAINTENANCE – IT EQUIPMENT AND REPAIR & MAINTENANCE – OFFICE EQUIPMENT UNDER THE OFFICE OF THE SANGGUNIAN SECRETARY TO TRAVELLING EXPENSES, TELEPHONE EXPENSES– MOBILE, OFFICE SUPPLIES AND OTHER SUPPLIES & EQUIPMENT OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Printing & Binding, Postage & Deliveries, Repair and Maintenance – IT Equipment and Repair & Maintenance – Office Equipment under the Office of the Sanggunian Secretary for CY 2021 amounting Fifty Three Thousand Pesos (P53,000.00);

Section 2. The total amount shall be transferred/ augmented as follows:

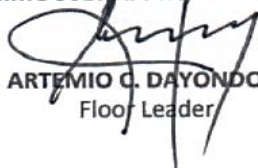
Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

ENACTED AND APPROVED on this 22ND day of December, 2021, during the 89TH Regular session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.

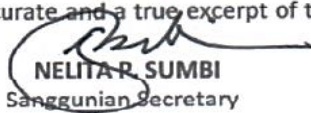
