APPROPRIATION ORDINANCE NO. 2022-03-039

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

“AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWELVE THOUSAND PESOS (P12,000.00) FROM THE APPROPRIATION FOR OTHER MAINTENANCE AND OTHER OPERATING EXPENSES UNDER THE OFFICE OF THE SANGGUNIAN SECRETARY TO MAINTAINING BALANCE OF SUPPLEMENTAL FEEDING ACCOUNT OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT OFFICE.”

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **Other Maintenance and Other Operating Expenses** under the office of the Sanggunian Secretary for FY 2022 amounting Fifteen Thousand Pesos (P15,000.00);

Section 2. The total amount shall be augmented to wit:

The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

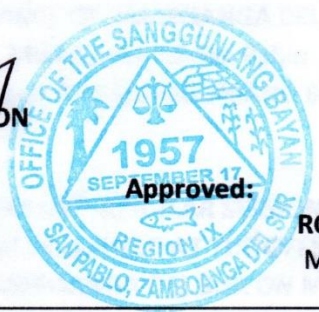
Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
