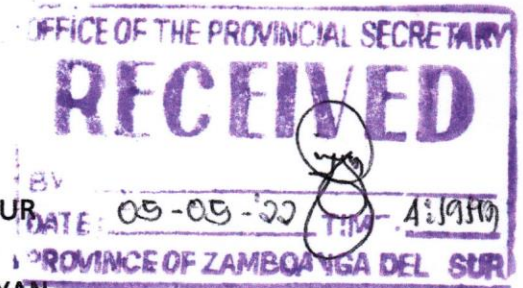

APPROPRIATION ORDINANCE NO. 2022-03-041

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. This Appropriation Ordinance shall be entitled ***“Surplus for the year 2021 of the municipality of San Pablo, Zamboanga del Sur.”***

Section 2. Sources of appropriation shall be taken from the ***“Surplus for the year 2021*** of the municipality of San Pablo, Zamboanga del Sur, as jointly certified by the Municipal Accountant, Municipal Treasurer and the Municipal Mayor, with a total amount of Seventeen Million Three Hundred Thousand Pesos (P17,300,000.00).

Section 3. The total amount shall be appropriated for the following:

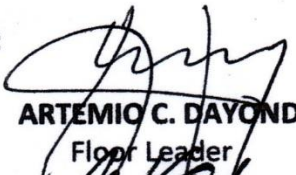
