APPROPRIATION ORDINANCE NO. 22-2023

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWENTY THOUSAND PESOS (P20,000.00) FROM THE APPROPRIATION FOR REPAIR AND MAINTENANCE OF IT EQUIPMENT UNDER THE OFFICE OF THE MSWDO- SAN PABLO, ZAMBOANGA DEL SUR TO TRAVELLING EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL **SUR IN SESSION ASSEMBLED:**

Section 1. There is an appropriation for REPAIR AND MAINTENANCE OF IT EQUIPMENT under the Office of the MSWDO, San Pablo, Zamboanga Del Sur, for CY 2023;

Section 2. The total amount of TWENTY THOUSAND PESOS (P20,000.00) shall be transferred to wit:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan, this 2nd day of August, 2023, during the 40th Regular Session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
